EXPLANATION FOR 2016 DEFICIT: In alignment with Generally Accepted Accounting Principles (GAAP) and FASB 116 (Statement of Financial Account Standards), all grants received by ACYI are recognized as revenue on the date of the grant award letter. In situations where the promised funds will be paid to ACYI in the future, that revenue is recorded as a receivable. On November 18, 2015, Adams County Youth Initiative was awarded a grant from the Daniels Fund in the amount \$199,100 for 2016 program costs, and the full promised amount was recorded in 2015, as required by generally accepted accounting principles. Please note the large surplus recorded during 2015 as a result of this award. As specified by the Daniel's Fund, ACYI spent the grant funds and properly recorded the expenditures in 2016; however, since the revenues related to these expenses were recorded in 2015 as required by generally accepted accounting principles, our financials show a deficit for the 2016 fiscal year.
