Other: The Rocky Mountain Partnership is led by the Steering Committee who provide strategic leadership, guidance and content expertise to the Partnership to ensure critical milestones in the work towards economic and social mobility are met.

RMP measures regional economic and social mobility through four indicators; poverty rates, overall employment rates, self-sufficient wage, and credential attainment because upward trends in these indicator areas are correlated with economic vitality. This approach is based on local and national research from groups such as the 2020 Colorado Talent Pipeline Report, the Lumina Foundation, the Brookings Institute, and the Pew Research Center. In 2020 RMP set its first shared global target toward achieving social and economic mobility, that by 2025, 50% (est. n= 193,000) of adults in Adams and Broomfield Counties will earn a post-high school certificate, credential or degree. This includes eliminating equity gaps between all racial and ethnic groups. This will result in an increase of an estimated 45,800 people in 5 years earning a post-secondary credential. This target is specifically intended to address the inequity experienced by Hispanic/Latino males in this region, of whom, only 11.2% age 25 or older hold a post-secondary credential. In order for this community to have a sustainable economic base, it is critical that the population is earning the skills, credentials or degrees to become employed at a self-sufficient wage. This target will help marginalized members of the community, particularly Latino males, to participate

in and benefit from the region's economic growth. When a person is able to attain a credential (skill, trade, apprenticeship, certificate, degree, etc.), they are more likely to be on a trajectory to earn a wage that allows them to support themselves and their families. This leads to declining poverty rates and a thriving economy. RMP looks at data in five domains; Basic Needs, Health & Mental Health, Social & Criminal Justice, Education & Training, and Economics & Workforce Development to form a holistic understanding of what is impacting economic and social mobility in the region pinpoint where to target the collective work in order to make the most impact. RMP's guiding framework is the Strive Together Theory of Action (TOA). The TOA measures a community's progress towards developing the civic infrastructure capable of achieving systems transformation. RMP is Colorado's only formally recognized Strive Together Network. The Theory of Action convenes cross-sector sector stakeholders and the community around a shared vision. Then community leaders and those most impacted by the systems in question set shared targets and co-develop short and long term solutions to achieve that vision. Collective Impact aligns policy, funding and resources to scale successful strategies to change systems, while also working to address immediate community needs that ladder up to the larger systems change work. In 2020, RMP served approximately 102,000 school aged children in Adams and Broomfield Counties attending Adams 12 Five Star Schools, Adams County School District 14, Mapleton Public Schools, 27J Schools, and Westminster Public Schools.
